#### CITATION TO ACCOMPANY THE AWARD OF BRONZE STAR MEDAL TO SERGEANT ELIZABETH A. KLOSS

FOR MERITORIOUS SERVICE AS THE TEAM LEADER OF HUMAN INTELLIGENCE COLLECTION TEAM 714, C COMPANY, 163D MILITARY INTELLIGENCE BATTALION DURING OPERATION IRAQI FREEDOM 06-08. INTELLIGENCE COLLECTION. EXCEPTIONAL KLOSS' SGT DEDICATION TO DUTY, AND **OUTSTANDING** UNOUESTIONABLE LEADERSHIP ENABLED HER TEAM TO PROVIDE TIMELY, ACCURATE, AND PREDICTIVE INTELLIGENCE RESULTING IN THE DEGRADATION OF ENEMY FORCE CAPABILITIES. HER SUPERIOR PERFORMANCE IN COMBAT REFLECTS GREAT CREDIT UPON HERSELF, THE 504<sup>TH</sup> MILITARY INTELLIGENCE BRIGADE, MULTI NATIONAL CORPS-IRAQ, AND THE UNITED STATES ARMY.

#### NARRATIVE TO ACCOMPANY THE AWARD OF BRONZE STAR MEDAL TO SERGEANT ELIZABETH A. KLOSS

SGT Elizabeth A. Kloss, United States Army, distinguished herself by exceptionally meritorious conduct as the team leader for Human Intelligence (HUMINT) Collection Team (HCT) 714, C Company, 163D Military Intelligence Battalion, at Forward Operating Base Paliwoda (Ali Ebin Abi Talib), Balad, Iraq from 13 August 2006 until 01 November 2007 in support of 3<sup>rd</sup> Battalion, 8<sup>th</sup> Cavalry Regiment (CAV) and Operation Iraqi Freedom 06-08.

In her capacity as an HCT Leader, a position traditionally held by a senior Noncommissioned Officer or Warrant Officer, SGT Kloss planned every aspect of her team's daily collection missions in response to her supported unit's Priority Intelligence Requirements (PIR), as well as Brigade, Division, Multinational Corps-Iraq, and national level PIR. She was directly responsible for the training and mission accomplishment of three additional HUMINT collectors, and one combat arms specialist. SGT Kloss and her team conducted their collection missions under a variety of arduous conditions outside the wire in a non-permissive and hostile environment, and were engaged by the enemy on multiple occasions. During the conduct of their operations, SGT Kloss and HCT 714 logged more than 1,500 miles on the treacherous roads of Salah Ad Din Province while conducting more than 90 combat patrols.

SGT Kloss built a diverse and effective HUMINT source network, cultivating a source registry of 40 level-two sources from the 15 sources left to her by the previous team. Through SGT Kloss' leadership and mentoring, HCT 714 produced more than 250 Draft Intelligence Information Reports and 30 SPOT reports. This reporting initiated numerous high-profile named operations conducted by 3/8 CAV, resulting in the death or detention of eight High Value Individuals and the detention or death of more than 50 additional insurgent members and facilitators. Her efforts also directly led to the seizure of 17 substantial weapon caches containing several hundred mortar and artillery rounds, thousands of small arms rounds, rockets, mortar tubes, rocket launchers, rocket-propelled grenades (RPG), RPG launchers, Iraqi Police and Iraqi Army uniforms, IED-making materials, two SA-7 Anti-aircraft rockets, and 30

As a result of her efforts, Coalition Forces were able to strike a major blow to the insurgency operating in Balad by removing persons responsible for countless attacks against coalition forces and civilians and severely depleting their weapon stockpiles.
